

Hudson Valley GCSA is the Rightful Champion at the 44th MET Area Team Championship

The 44th MET Area Team Championship returned this fall to Tamarack Country Club, where thirteen regional golf course superintendents' associations from the Metropolitan, New England, and Mid-Atlantic regions teed it up for one of the industry's most competitive and camaraderie-filled events. On a crisp autumn day over Tamarack's classic par-70 Charles Banks design, the Hudson Valley Golf Course Superintendents Association (HVGCSA) emerged victorious, carding a team total of 285, five strokes clear of their nearest challengers.

Scoreboard Confusion Adds Some Drama

As scores began to roll in, what appeared to be a smooth finish turned chaotic. Due to a computer entry issue, two groups mistakenly submitted net scores instead of gross scores on their official cards, which means 4 teams had incorrect scores posted. When those numbers were entered into the scoring software, the teams were inadvertently credited twice for strokes, causing a jumble on the leaderboard. Tournament staff identified the error after the fact, double-checked the cards, and recalculated the affected totals. Unfortunately, prizes were handed out and gift cards were cashed before the errors were discovered and corrected the following day. At the awards dinner, the Northeastern GCSA was inadvertently awarded first place when in fact, they came in second. Scores were corrected on the 21st and the Hudson Valley and Northeastern groups were notified. Northeastern GCSA will pass on the trophies to the Hudson Valley association as soon as possible ensuring the Hudson Valley GCSA's wellearned victory was properly recorded.

While it created a few tense moments on the scoring, the corrections were met with good humor among the teams

— a reminder that even in a precision-minded profession like turf management, a little human error can still sneak in.

Scoring also affected the skins results as well and were announced the day after the event and paid out with only 1 Net skin and 1 Gross skin surviving!

Congratulations to our skins winners! Chris Kemble took home the net skin with an eagle on Hole 10, while Dave Lippman captured the gross skin with a birdie on Hole 2. Well played, gentlemen!

Championship Recap

Cool, clear weather with some wind, and firm conditions made Tamarack a true test of precision and patience. The course's signature squared-off greens and deep bunkering demanded accuracy on approach, while the fast, rolling greens punished even the slightest of misreads.

It was Hudson Valley's Net partners of Brent Thompson and Chris Kemble leading the way with a 6 under par 64, followed by the other Net pair of Reese Wasson and Will O'Brien at 68. On the Gross side the team of Steve Whipple and Joe Meyer shot 76 followed by Dave Lippman and Grover Alexander at 77. All around consistent team play allowed them to secure their second ever victory, their first coming in 2012 at The Stanwich Club. David Lippman said of their victory, "it was a total team effort! Everybody was jiving with their partners all day. The course was amazing and very brutal in the wind! Patience and fortitude won the day!"

When all the scoring was corrected it turns out this year's championship was a tightly contested battle with only 3 strokes separating 2nd place through 8th place! Tie-breakers had to be used at all those positions all the way to 10th place! Ties are broken by each teams combined Gross scores, followed by their combined Net scores. The Northeastern Associations gross team scores were 2 ahead of New Jersey's on the tiebreaker giving them second place while New Jersey secured 3rd spot, just 2 strokes ahead of a log-jam at 293. Three associations had to use the tiebreaker to determine 4th place which was awarded to the Philadelphia Association! Congratulations to the top four teams in this


Labor continues to be a struggle for many superintendents in the northeast. Whether attracting them or retaining them, the process is difficult and often costly. The days of placing an ad in a newspaper (for the senior members of the industry) or even expecting a response from Indeed or other online jobsites are no longer a viable option. Does that mean it is impossi-

ble, no. What it has turned into is work. Yes, you have to expend a lot more effort to acquire employees of any talent level. Where to look and GCSAA resources to offer can help make it easier and more effective.

GCSAA has made a concerted effort to engage the million participants in FFA. Young people enamored with outdoor interests are a logical target for golf course maintenance. GCSAA visibility at the national conference has been happening for years now and visiting state conventions are on the rise. Do you have a local FFA near your course? A visit to the golf course would fit their learning model and offer you a viable touch to possible or future employees.

Our mission at GCSAA to "enhance the enjoyment, growth, and vitality of the game of golf" cuts right to the heart of this matter. The First Green initiative is about opening our courses as a science lab to young students. Access to our property and game may never happen otherwise. Showing them what we do at our facility and how we do it is a key step to a possible future with golf in it. New Hampshire Learning Initiative commissioned a Gallup poll regarding career-connected learning (The Power of Career Connected Learning in New Hampshire):

Students who agree that the career activities at their school include the types of jobs and careers they're interested in are more than **three times more likely** to agree that the CCL opportunities at their school have informed what they plan to do after high school than those who do not agree.

Looking to increase wages for critical staff such as your assistant or equipment manager? Employee's first time on a golf course or new to your team. Take advantage of the training videos (English and Spanish) as the first step. Eleven tasks included, with "This is a Golf Course" for those who have never been on a course before!

Engaging young people (even as young as middle school) alerts them to our industry, increasing the chances of them looking at a career in golf course maintenance. Educating them once they are engaged is critical to their success. While not easy to do either for the superintendent, resources to achieve both are becoming easier for you to benefit from!

HVGCSA Delegate Meeting Update

October 27–29, 2025 | GCSAA Headquarters, Lawrence, Kansas



Greetings HVGCSA members,

I just want to provide a quick update from this year's delegate meeting, which took place at the GCSAA headquarters in Lawerence Kansas on October 27-29 of 2025. This year 89 of 91

associations were represented from all across the US. The meeting was very productive as it introduced Colonel John Morley's founding vision back in 1926. Yes, the GCSAA turns 100 this coming 2026!!

The GCSAA now has over 20,000 members, which shows the strength of our industry, and it is projected to grow as we reach out to have more Assistant Superintendents and Equipment managers join. Another large undertaking is the implementation of the BMP (Best Management Practices) program. It has been around for a while, but it is becoming more common and will most likely become a staple that we all should be doing. Just giving the heads up now so if you haven't done so, reach out to myself or GCSAA Northeast regional field representative Kevin Doyle for more info.

The delegate meeting as a whole is a great way to learn more about what the GCSAA does as well as give you the opportunity to network with other superintendents from all over the country. The meeting is very compact and detailed and well structured. There are basically 3 parts to the meeting.

Part 1 (Monday evening) This includes the welcome reception and dinner. This is where they update progress from last year's meeting and go over the topics for the next day's meeting.

Part 2 (Tuesday morning) General session in an auditorium style seating area with the breakdown of what's to be discussed in the "breakout sessions" These breakout sessions are smaller groups that discuss the topics more in depth, detailed and to the point with a staff member taking notes to follow up with later.

Part 3 (Tuesday afternoon) General session in same auditorium but this is to discuss the new GCSAA members running for office. They have about 4 or 5 minutes to talk to the delegates and discuss who they are or why they are running. Then another breakout session to meet each candidate more in depth and we can ask then more detailed questions about them running for office.

I strongly encourage anyone who's not a member to join the GCSAA and if you are already a member, I strongly encourage you to attend a delegate meeting at least once, but you will get more out of it the second time. If anyone has questions about joining the GCSAA or attending the delegate meeting don't hesitate to contact me.

A Legacy of Leadership in Turfgrass Management

The New York State Turfgrass Association (NYSTA) was established on March 4, 1949, during the Second Annual Cornell Turfgrass Conference in Ithaca, New York. One of its founding members, Professor John Farnsworth Cornman of Cornell University's Department of Ornamental Horticulture, played a pivotal role in its creation. Under Professor Cornman's leadership, Cornell initiated teaching, research, and extension programs in turfgrass management beginning in 1940. NYSTA's original mission was to "develop an attitude of solidarity among those interested in turf; promote the advancement of turf culture throughout New York State; address the collective challenges of turf professionals; disseminate information on best practices; and advance education and instruction in turf management." As we flash forward to 2025, now more than seven decades later, NYSTA continues to uphold the core principles upon which it was founded — Education, Advocacy, and Stewardship.

Education

NYSTA provides numerous opportunities for professional development through New York State Department of Environmental Conservation (NYSDEC) accredited programs. These include in-person educational conferences and nine winter webinars. Members enjoy significant benefits — including savings of up to \$540 in webinar registration fees — while earning valuable DEC credits toward applicator licenses.

Advocacy

NYSTA actively represents the interests of turf and green industry professionals at the state level. Working closely with the New York State Green Industry Council, NYSTA advocates for fair regulation and legislation that supports and protects the green industry. Through its engagement in the New York State Assembly and Senate, NYSTA ensures that the voices of turf professionals are heard and their livelihoods safeguarded.

Stewardship

NYSTA fosters connections with experts across the turfgrass

industry to address the environmental challenges members face. A prime example of this commitment is NYSTA's leadership in developing Best Management Practices (BMPs) for New York State golf courses. Funded by NYSTA's Turfgrass Environmental Stewardship Fund and developed in collaboration with Cornell University and industry professionals, these BMPs have set a national precedent — positioning New York as one of the first states to implement comprehensive standards that strengthen both stewardship and advocacy efforts.

Additional Programs and Achievements

Turfgrass Environmental Stewardship Fund (TESF) This fund enables NYSTA to support turfgrass research and provide educational assistance to local chapters, advancing scientific understanding and professional development across the state.

NYSTA Apprenticeship Program

Now entering its third year, this New York State-registered program helps green industry employers train and invest in key employees at minimal cost. The program continues to grow in popularity and success, equipping the next generation of turf professionals with the knowledge and skills needed to thrive.


