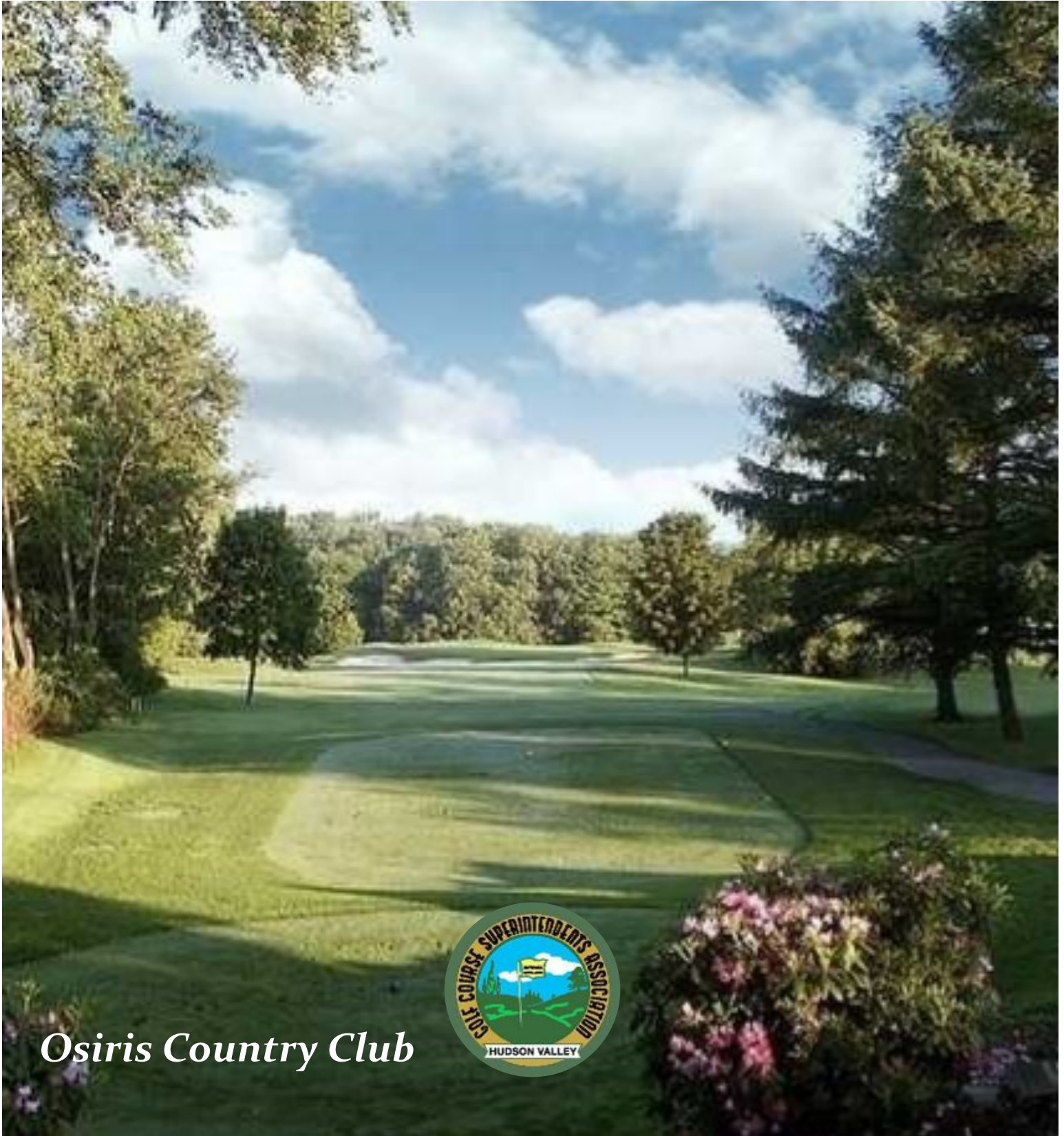

Osiris Country Club to Host October Meeting & Worthington Cup Tuesday, October 7, 2025

On Tuesday, October 7th, Osiris CC and Superintendent Reese Wasson will host “The Worthington Cup”. The Worthington Cup is named after Ed Worthington Jr. (Westchester CC Superintendent Dave Dudones’ grandfather). There is some great history here.

Dave’s great-grandfather, C.C. Worthington, was an inventor and an avid golfer who, in 1907, hired his good friend A.W. Tillinghast to design and build his first golf course, Swawnee CC, located in Swawnee-On-Delaware, PA. Worthington, after being shown a homemade gang mower by Tillinghast, tinkered and improved upon the design and formed the Worthington Mower Company. The company, which provided high quality tractors and mowers for commercial use, was eventually sold to Jacobsen in the mid-1940’s.

Dave’s grandfather, Ed Worthington Jr., founded the Ed Worthington Corporation (a turfgrass supply business located in Saranac Lake, NY) in the 1940’s. Ed would travel the Hudson Valley region in a station wagon selling chemicals, fertilizer, and seed to the local superintendents. Ed was literally the first “Lesco” and was beloved by his customers. After Ed retired, the HVGCSA honored Ed by holding an annual tournament in his name.

The Golf Course:

Osiris opened for play in 1927. The original nine-hole golf course, built by the membership, was characterized by its small greens and flat “parkland” design. A second nine, designed by Frank Duane, was added in the 1960’s. The second nine is characterized by rolling fairways, elevation changes, and large well bunkered greens. In the 1990’s, Architect Steve Esposito added his touches on the original nine and reconfigured three holes. And, just a few years ago, three new holes were added to the front nine to accommodate some future building lots. One of those holes was just returned to the original par-3 it replaced. Osiris plays 6400 yards from the back tees.

Reese Wasson was hired in the winter of 2023 by a new ownership group to manage the golf course. Since Reese took over as superintendent, the clubhouse has been completely renovated, an aggressive tree removal program was instituted for the golf course and, in the short term, a plan to improve course conditions course-wide was implemented. Future long term plans include an irrigation upgrade and a tee renovation process.

Osiris is a fun track to play. Holes of note include the 13th, a 450-yard par 4. From an elevated tee,

you'll want to avoid the bunkers left and right of the landing area. If you can find the fairway with your tee shot, your approach is to a green guarded on the right by a large oak tree and a bunker left. The putting surface slopes severely from back to front.

The 3rd hole is a 375-yard dogleg right par 4. The tee shot is to a narrow tree lined fairway. The approach shot to the green demands accuracy. A large bunker guards the front of the green. There is a pot bunker left and if you fly the green you'll most likely be out of bounds, so don't go long!!

About Reese:



Reese grew up in Middletown, NY. You would think that he would have been like so many of the superintendents in the Hudson Valley area, working at a local golf course in high school and finding their future profession but that didn't happen with Reese.

"I didn't think about golf until I was in college," Reese said, "I was at U.R.I. and decided to change my major to Turfgrass Management. I had never worked on a golf course. My first real experiences were my internships. I did my first one at Orange County GC (now West Hills) in Middletown, NY and my second at Manchester CC in Bedford, NH.

In 2004, Reese graduated and was hired at Hamlet Golf & CC in Long Island as an assistant. "My first boss was Ken Lochridge (now at Glen Head CC). Ken left and they offered me the superintendent's position in 2008. I stayed there for four years until Club Corp took over the management of the facility. I knew it was time to leave," laughed Reese.

Reese worked as an assistant at Colonial Springs CC on the Island for a couple of years when, in 2014, the superintendent's position opened up at Winding Hills GC in Montgomery, NY. It was time to come home.

"I spent four years at Winding Hills and really enjoyed it," Reese said, "In 2018, the superintendent's position at Spook Rock GC opened up and I applied for it and got it. It was run by a management company, Applied Golf. They were good to work for and never micromanaged me. They left me alone to do my work and all they expected was that we keep the course in good condition."

In 2023, Reese took on the position of superintendent at Osiris. A new ownership group bought the golf course and needed a professional like Reese to lead them into future.

In addition to all the demands on Reese at Osiris, Reese has been active in the Association and, this year, is finishing up his term as the HVGCSA's President. Reese lives in Middletown, NY with his wife Nicole and their two daughters, Everly-6 and Brinley-1.

We'll see you at Osiris on October 7th!!

NY Economic and Environmental Impact Study

Congratulations to all the New York superintendent associations on the completion of the Economic and Environmental Impact study. The significant value the



golf industry brings to the state of New York will not go unnoticed! I personally am looking forward to NYSTA Lobby Day again in 2026 and using this information for continued success.

GCSAA needs your help to do the same at the national level. The Golf Course Environmental Profile is a groundbreaking project launched in 2006 to develop a comprehensive environmental profile of golf courses in the United States. GCSAA held meetings with a wide range of industry groups that identified a need for this data. The industry faces issues ranging from land use to regulations and practices governing water use, nutrients, and pest control. Prior to the GCEP, the industry faced a critical need for accurate data on the land use, inputs, management of natural resources and environmental stewardship associated with golf courses in the United States. Used in part to help advocate for golf course professionals and the golf industry, the profile – articulated in reports and surveys – conveys accurate data on the land use, management of natural resources and environmental stewardship associated with golf courses across the country. The quest for vital data continues on:

Complete the Nutrient and Pest Management Survey by Nov. 10

Your participation in GCSAA's Golf Course Environmental Profile Nutrient and Pest Management Survey is critical to the future of the game of golf. All superintendents, including non-GCSAA members, should participate in this critical survey and ensure that the profession and industry are well represented by all course types, budget levels and locations. Individual survey responses are not disclosed nor does GCSAA sell email addresses.

How to participate

Superintendents should check their email inboxes or spam filters for an email sent on GCSAA's behalf by the National Golf Foundation (NGF) for their individual access to the survey. The data from the survey will provide much-needed facts that enable GCSAA to advocate on behalf of the profession and industry to maintain the resources needed to ensure success. Without the data, we can't provide the facts behind what we say about golf's and the superintendents' professionalism and environmental stewardship. If you did not receive the email, you can still access the survey through Nov. 10.

aggregate data. Individual facility data will not be shared or disclosed.

Key points

The Golf Course Environmental Profile is owned and copyright protected by GCSAA. Data should be properly cited for publication, presentations, etc.

Phase IV is funded through the GCSAA Foundation with support from the USGA.

GCSAA intends to publish the survey in peer-reviewed journals.

NGF will conduct, process and analyze the data on behalf of the GCSAA as a third-party and independent entity who will follow the market industry standards to ensure valid survey results.

Travis Shaddox, Ph.D., president, Bluegrass Art and Science LLC, and J. Bryan Unruh, Ph.D., Extension turfgrass specialist, University of Florida, West Florida Research and Education Center, will provide technical oversight, analyze data, and write publications including the peer-reviewed manuscripts, public reports, and GCM articles.

All participants' individual survey results are not disclosed or shared. Results are reported in aggregate only. In addition, GCSAA does not sell email addresses.

As third parties, the scientists will work to ensure that the scientific methods associated with data collection and reporting are valid.
